APPLICATION

Lawn > 2 to max 3 times 70 to 100 g/m² from the start of the growing season until the end of August. Application either by hand or with a spreader with maximum spread rate adjustment. Subsequent irrigation is advantageous, but only required during dry periods

Vegetables > depending on the nutrient requirements 2 times 100 to 150 g/m². It is advisable to apply the first dosage 7 to 10 days before sowing or planting to incorporate it into the soil. The second dosage is applied in the middle of the growing period of the culture.

Flowers > a good planting substratum with lots of humus and clay content is crucial for good growth of flowers. 10 to 14 days before repotting 1kg/100l of Bionatur should be evenly mixed into the substratum. According to the growth rate, a second fertilization is required when the flowering period is about halfway through. Application rate of approximately 1 to 2 handful per meter.

Ornamental plants and shrubs > at begin of vegetation evenly spread 100-150 g in the plant area.

The guidelines for proper fertilization of the Advisory Board for Soil Fertility and Soil Conservation at BML Federal ministry of Agriculture have to be considered in the assessment.

Maximum amount of nitrogen for organic farming is limited to 170 kg/h.

Fruit, yield plants	500-700 kg/ha	In late autumn or spring
Tomatoes	900-1200 kg/ha	Before cultivation
